



Re:

Enclosed please find the request of Gulf Coast Racing, LLP ("GCR") for allocation of live race dates for Period #2 (January 1, 2013 through August 31, 2013). Specifically, the request seeks race dates for August 27 through 31, 2013. GCR hereby requests an extension of time for submittal of this request. In the alternative, and to the extent you believe it is appropriate, GCR requests that you accept this Request for Approval of Live Racing Dates, pursuant to Texas Rule of Racing § 303.41(j).

GCR has been in negotiations with the management of Gulf Greyhound concerning the possibility of that track hosting live race days (in addition to Gulf Greyhound's own calendar) in lieu of GCR running those days at Gulf Coast Racing. These negotiations have been encouraged by the Commissioners as a means to create additional racing opportunities to the benefit of the Texas greyhound industry. Accordingly, the live race dates requested by GCR are necessarily directed by the dates requested by Gulf Greyhound. In order to determine when additional dates are available to conduct GCR's race days, Gulf Greyhound must first know which days it is requesting for its own calendar. As of this date, Gulf Greyhound has not yet submitted a request for race dates due to ongoing discussions with the Commission. This has complicated and delayed GCR's request for race dates. Because the status of Gulf Greyhound's race dates remains unsettled, GCR has determined that it is appropriate to request race dates without further delay.
